STRUCTURE, GOVERNANCE & MANAGEMENT

2024/25 TRUSTEE REPORT can be found here

The Groups governing documents are those of The Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Association and The Policy, Organisation and Rules (POR) of The Scout Association

The Group is a trust established under the rules which are common to all Scouts. The Trustees are appointed in accordance with the POR of The Scout Associations.

The Group is managed by the Group Trustee Board, the members of which are the "Charity Trustees" of the Group which is an educational charity. As Trustees they are responsible for complying with legislation applicable to charities. This includes registration, keeping proper accounts and making returns to the Charity Commission as appropriate.

The Trustees consist of the Chair(s), Treasurer and other Elected Trustees.

They are supported by the Group Lead Volunteer and Assistants, individual Section Leaders, Parent and Young Person representatives, meeting a least three times per annum.

Trustees complete "Essential Information for Executive Committee" training within the first 5 months of joining the Board.

This Group Trustee Board exists to support the Group Scout Leader in meeting the responsibilities of the appointments and is responsible for:

- The maintenance of Group property
- The raising of funds and the administration of Group finance
- The insurance of persons, property and equipment
- Group public occasions
- Assisting in the recruitment of leaders and other adult support
- Appointing any sub committees that may be required
- Appointing Administrator's and Advisors other than those who are elected

RISK AND INTERNAL CONTROLS

The Group Trustee Board has identified the major risks to which they believe the Group is exposed and this has been reviewed on 13 June 2025. The main areas of concern that have been identified are:

- Damage to the building, property and equipment. Sufficient insurance is in place to mitigate against permanent loss.
- Injury to leaders, helpers, supporters and members. The Scout Association provides a national accident insurance policy as part of the annual capitation paid by the Group.
- Risk Assessments are undertaken before all activities
- Reduced income. The Group is primarily reliant upon income from subscriptions. A reserve is held to ensure the continuity of activities should there be a major reduction in income.
 Subscriptions could be raised to increase income on an ongoing basis.

- Reduction or loss of leaders. The Group is totally reliant upon volunteers to run and administer activates. There would have to be a contraction, consolidation or closure of a section. In the worst-case scenario, the complete closure of the Group
- Reduction or loss of members. There would have to be a contraction, consolidation or closure of a section. In the worst-case scenario, the complete closures of the Group

The Group has in place systems of internal controls that are designed to provide reasonable assurance against material mismanagement or loss. These include two signatories for all payments and comprehensive insurance policies to ensure that insurable risks are covered.

ANNUAL GENERAL MEETING – 1st Stanmore Scout Group

06 September 2024 Meeting Minutes

1. WELCOME, OPENING REMARKS AND TRUSTEE REPORT

Vipul Mehta (VM) and Shailesh Vekaria (SV)

VM and SV welcomed everyone and introduced Trustees and special guest Reshma Patel Lead Volunteer from Harrow District.

SV explained that the purpose of the AGM is to formally approve and adopt the annual Trustee reports and accounts to year end 31 March 2024 (circulated ahead of the meeting via OSM), in line with the requirements of the Charity Commission's Guidelines.

2. APOLOGIES FOR ABSENCE

Gillan Barnard – Deputy Lead Volunteer Harrow District. (Our liaison with the district) **David Huntley** – Assistant Scout Leader

3. MINUTES FROM LAST AGM 06 October 2023

Proposed by VM, seconded by Ashley Martin (AM). Attendees voted all in favour with no questions arising from the minutes of the last meeting.

4. GOVERNANCE - VM

VM explained the changes in Scouting Governance this year including changes to titles and references and the requirement to agree and adopt the following:

- a. <u>Policy, Organisation and Rules (POR)</u> (issues to the Council ahead of the meeting to review on the Scout Association Website), proposed by VM, seconded by Lizzie King (LK) and agreed unanimously by the Council.
- b. **Maximum number of Trustees on the Board** (minimum requirement of 5). VM proposed maximum of 9, Bhrat Patel (BP) seconded and agreed unanimously by the Council.
- c. **Quorum required for AGM.** VM proposed minimum of 10, AM seconded and agreed unanimously by the Council.

5. GROUP LEAD VOLUNTEER'S REPORT – Ashley Martin

Ashley firstly noted that it has been a privilege to lead 1^{st} Stanmore as GLV in what has been a fantastic year with the group growing in numbers for a 3^{rd} year running.

It has been a brilliant year of activities a highlight of which was Scouts joining the Jamborette in Harlem last summer, representing the first time in several years that 1st Stanmore has taken part in an international event. We are hoping to be able to repeat this in 3 years at the next event.

AM thanked all of the Leaders and volunteers and paid tribute to those who have stepped down after committed and much appreciated service this year, particularly Duncan McDowall (Scout Leader) and Rob Curtis (Treasurer). AM reflected gratefully on the personal support given to him.

AM reminded the Council that the group is run fully by volunteers, and it is a very very small and diminishing team of volunteers and parents without whom we would not exist and made an urgent appeal for anyone with time and / or skills to come forwards.

6. GROUP TRUSTEE REPORT – VM

The report including the financial statement reviewed independently, was issued to the Council ahead of the AGM.

7. FINANCIAL REPORT – Ona Jomaa (OJ)

OJ presented the financial report, including total income and outgoings, reserves, and risks.

OJ reported that the financial position of the Group is stable and healthy and the year ended with surplus.

During the reporting period, a flood in our Scout Hut resulted in approximately £11,100 of repairs. £8,200 of which we recovered from our insurers.

As we are a charity with income of less than £250,000 we prepare our annual statement on the basis which summarises the movement of cash into and out of the Trust during the financial year.

OJ reported that she considers the 1st Stanmore Scout Group is in good financial position to continue.

There were no questions from the floor.

SH proposed the accounts, seconded by Jackie McDowall (JM) approved unanimously by the Council.

8. APPOINTMENT OF TRUSTEE BOARD

SH explained that the role of the Trustee Board is to ensure that the group is well governed, meets compliance standards and creates and runs a fulfilling and safe programme of activities for our young people. The Board will oversee the governance of the charity for the next 12 months.

In addition to this AGM. the Trustee Board meets 3 times a year, near the start of each term. Our function is to review and approve programmes, keep an eye our finances and purchasing decisions and generally support the leadership team in delivering the Scouting Programme.

- Chair: GLV AM thanked VM and SV for working so well and hard together to Chair 1st
 Stanmore for the last 2 years. AM expressed it as his privilege to propose VM who has been volunteering for 14 years as Chair, seconded by Ramesh Dave (RD) and agreed unanimously by the Council.
- Treasurer: VM thanks OJ for stepping in as Acting Treasurer after RC resigned and for all of her hard work in managing the Group's financial transactions and subs collections through the year. Sadly, OJ will be stepping down herself this year. VM proposed SV to be appointed as Treasurer, AM seconded and agreed unanimously by the Council. VM thanked SV for stepping in and all of his hard work as Co-Chair.
- Trustee Board (min 5 required). VM proposed Jigna Patel (JP), Bhrat Patel (BP). Ramesh Dave (RD) and LK seconded, agreed unanimously by the Council.
- Independent Reviewer: We have not had any volunteers to perform this critical role ahead of the AGM. AM proposed to proceed with agreement from the Council that we will appoint someone by the end of the financial year. LK seconded agreed unanimously by the Council.
- SV noted that JM will be stepping down from the Group Trustee Board to focus on her Beaver section, the Board thanked Jackie for her dedication and time commitment without whom the Beaver Section would not have grown or even exist. JM was thanked by all with applause.
- SV appealed for further nominations to volunteer as Trustees or parent helpers. We particularly need representatives from different sections.

10. KEYNOTE, DEPUTY DISTRICT COMMISSIONER RESHMA PATEL (RP)

RP thanked all for their service and attendance on behalf of Harrow District and Gillan Barnard, District Commissioner.

In her role RP works with all 31 Groups in the District and personally thanked all of the Leaders at 1st Stanmore and praised their commitment as well as their immense support to her and the District to continue to achieve fulfilling programmes. Reshma reflected that the number of awards and particularly the Chief Scout Bronze, Silver and Gold Awards are a reflection of the dedication of the Leaders to provide a high quality of programmes and dedication to each child. For this RP gave praise to JM, BP and LK and their teams, reflecting that these awards are not easy to get.

RP reflected on all of the hard work that goes into planning each camp. 3 -12 months in advance compliance, safeguarding, risk assessments all have o be managed alongside logistics, equipment, communication and administration – in addition to the hard work at, and after camps – while planning and running weekly meetings with enriching programmes. All volunteers are also busy working people with families and other commitments but give up their time so willingly.

RP echoed the appeal of the 1st Stanmore Trustee Board for more volunteers and helpers, no matter what time or skill commitment can be offered.

AM paid tribute to Jack Petchey who sadly died at the age of 99 this year, his foundation continues to do fantastic work for the benefit of young people who would not otherwise have the opportunity to access such varied and rewarding activities.

JP paid tribute to AM. Without AM the Group would not have survived recent turbulent times. AM has been critical to maintenance at the hut especially after the flooding we experienced last year and the driving force behind organising the successful Harlem camp. JP addressed the Young People in the room and reflected that in the 15 years that she has known AM as an assistant Scout Leader himself she has drawn inspiration from AM, his lifelong commitment not only to Scouting, but to the Group and District. AM's standout qualities include respect for his Leaders and influencers that have driven him to give so much of himself no matter what back to his community carrying on the legacy of his family. JP appealed to the Young People to follow in AM's inspirational footsteps.

RESERVES POLICY

Given the age of our building it is likely that major roof works will be required at some point in the future and the Trustees consider it prudent to hold funds on reserve to cover this.



GROUP LEAD VOLUNTEER REPORT ASHLEY MARTIN

2024 to 2025 has been another fantastic year at the first Stanmore.

We have implemented all of the new Scouting Association governance model requirements and with a dedicated team of Trustees and Leaders have made significant progress in advancing items such as building works to the fence to secure our site, upgrading our IT and alarm systems and improving our Data Protection measures.

Although overall we have not grown in numbers we have achieved the numbers above what we require to be viable and continue to recruit. The numbers now included our new very successful Dragons Unit run in conjunction with 1st / 6th Edgware, that has given all of our scouts a pathway to continue their scouting journey in a new and exciting way. Events: Throughout the year, the Cubs engaged in several memorable events:

- Water Activities Day: A fun-filled half-day spent on the water where Cubs participated in various water-based activities, enhancing their teamwork and water safety skills.
- Space Camp @ PACCAR: A fun district arranged camp focused on science and space-themed activities. This camp will be remembered for the weather by many of the Cubs. Despite it being early July somehow nature conspired to send lots of rain our way including thunder and lightning on the last day. It must have surely been the wettest July weekend in decades!
